

Regarding Staff Report # 3 "Early Budget Approval for IRM"

My name is François Brassard and I live at 1162 Bewdley Ave in Esquimalt.

Honourable Mayor and Councillors,

As a member of ECO, I wish to speak in strong opposition to the Recommendation stated in Staff Report #3 regarding the "Early Budget Approval for IRM."

In my view, this recommendation is an obstructionist tactic that would delay and deny what this Council unanimously put forward in November of last year regarding Esquimalt's waste management program. More than 80% of Esquimalt residents support this IRM project.

To delay this project would result in serious consequences in terms of GHG reductions, one of which is the CRD expansion of the Hartland landfill with its destruction of 73 acres of mature trees.

Achieving carbon neutrality requires bold action. The status quo cannot prevail. Esquimalt needs to be congratulated in making the first bold steps on the waste to energy project. Getting on with the final study will enhance the Township's reputation as a leader in the CRD.

Therefore, I would urge Council to give early budget approval to study and investigate the implementation of Integrated Resource Management with a project budget of \$100,000.
