PART I - VISION

The new Council for the Corporation of the Township of Esquimalt met on January 6th and 7th, 2006 to identify Council's Municipal Objectives.

In order to ensure Council's objectives had focus, Council began their deliberations discussing a vision for Esquimalt's future.

Vision discussions began by reviewing the following "Community Vision Statement" developed by a group of Esquimalt citizens in 2003/2004:

Esquimalt is a diverse community, a desirable place to live and an integral member of a larger region.

We encourage meaningful community participation and consultation to provide open and responsible decision making. We enhance responsible economic opportunities and embrace sports, recreation, the arts and the west coast lifestyle.

As we achieve the vision, we enhance our quality of life; enjoy health and safety; build upon our cultural heritage; revitalize our community; protect our natural environment and foster our diversity.

Council's vision of Esquimalt includes specific details. Indeed, Council's long-term vision centers around a number of points of consensus:

Esquimalt is a self-contained "town" within a larger urban area with a unique sense of community. Esquimalt has overcome its past reputation as a rough town and is a safe community to live, work and play in. With all that Esquimalt now has to offer, residency in Esquimalt is a preferred address within the Capital Region.

- Esquimalt's natural advantages are a key attraction to its residents who love to be surrounded by, and have access to, the sea; live on a southwest exposure on varied terrain. Esquimalt's proximity to downtown Victoria is a key attraction, particularly as through traffic is minimal and focused on the single Craigflower corridor.
- Esquimalt's public facilities are also a key attraction to the community. An outstanding Recreation Centre is complimented by a complete library and by numerous parks offering a wide variety of experiences.
- The local services available to Esquimalt's residents continue to expand. Esquimalt's growing population, coupled with the growth in neighbouring Vic West, generates new opportunities that all can take advantage of. First-class services are available to young families, and Esquimalt schools are refurbished, offering comprehensive educational opportunities.
- Housing opportunities in Esquimalt are varied. There are multiple forms of housing as Esquimalt densifies in order to maximize affordability. A variety of tenures exist including rental housing. With the varied housing, Esquimalt is home to young families, seniors and hard to house segments of society.
- The people of Esquimalt are a varied group who welcome additional diversity. Residents, including members of the military, are actively engaged in their community. Residents volunteer, participate in community initiatives and work at maintaining Esquimalt's sense of community. Residents are proud of Esquimalt's unique history and support an active cultural community.
- Sustainability is a key objective of the community of Esquimalt. The community is environmentally aware, practices stewardship, has a social conscience and is financially responsible.
