# **POSITION FUNCTION**

This is skilled work in general park maintenance. Work includes planting, pruning, hedge trimming, watering and general arboriculture and horticultural maintenance of a variety of coniferous and deciduous trees. Performance is evaluated in terms of quality of work and adherence to established standards.

# **TYPICAL DUTIES**

Maintain park areas; hand weed and edge lawn areas, tree pits and flower beds; dig, mulch and prepare soil for plants; monitor and control pests through application of pesticides; mow and aerate grass; use weedeater and brushcut semi-wild areas and access paths; empty garbage cans in parks and pick up litter from parks grounds.

Inspects trees, prepares and maintains a tree inventory, identifies such items as type, size, condition, diseased, over-mature and problem trees; determines and recommends required treatment such as limbing, pruning or removal.

Maintain and construct pathways.

Prunes, shapes and performs other maintenance tasks on Township trees and hedges, often on ladders and in a bucket truck.

Plants, stakes, fertilizes, mulches and waters trees and shrubs.

Removes trees using appropriate felling techniques and equipment; cuts and removes stumps and performs heavy manual duties related to the work. Safely operates a chipping machine, chainsaw and stump grinder.

Reports indications of hazardous trees, tree pests and diseases to a supervisor; as directed, applies herbicides and pesticides.

Assists with the issuance of permits related to the cutting or pruning of trees.

Carries out routine maintenance on equipment. Plan change of plants and trees; Plan and design flower bed layout; select plants; plant annual bedding displays; plan seasonal clean-up of park areas.

Operate a vehicle for transport of equipment and supplies to and from job sites; perform minor maintenance to irrigation system; load and unload material and equipment manually from truck such as bins of grass; use hand tools and operate equipment such as spade, fork, cultivator, pruner, power lawn edger, lawn mower, backpack sprayer, generator and lawn aerator.

Respond to enquiries from the public regarding plantings; contact suppliers for availability of plants and material; provide instructions and information to other staff as required.

As required, provides direction to other employees assisting in the work.

Performs other related duties as required..

# **INDEPENDENCE**

The incumbent exercises some independence of action in the technical functions of the work, directs other employees assisting in the work and must exercise considerable care to ensure the safety of the operations. Verbal and written assignments are received from a supervisor who checks the work during progress and upon completion for the attainment of desired results. Work is performed according to established guidelines or assigned by supervisor.

Work is reviewed while in progress by supervisor.

Issues such as major renovations, removal of large or established plants or trees and expenditures for new plant equipment and material are referred to supervisor.

Understand and apply the methods and procedures of horticulture.
